

#### 4. Test Condition

(1) Put the samples in  $105^{\circ}$ C and dry for 1 hour, then cool to room temperature in a desiccator. Weigh and record the quality.

(2) Put the samples into the DI water of room temperature for 24 hours. Then remove the samples from DI water, wipe off the surface of water droplets and weigh, the final calculation of the incremental percentage (water absorption).
